#### **SECTION 1 – MEDICAL CONSENT**

I ALSO UNDERSTAND THAT IN SUCH AN OCCURRENCE THAT ALL REASONABLE STEPS WILL BE TAKEN TO CONTACT ME OR THE ALTERNATIVE ADULT, WHICH I HAVE NAMED ON THE FORM. ***I CONFIRM THAT TO THE BEST OF MY KNOWLEDGE, MY CHILD DOES NOT SUFFER FROM ANY MEDICAL CONDITION OTHER THAN THOSE DETAILED BY MYSELF ON THE FORM***

#### **SECTION 2 – PHOTOGRAPHIC CONSENT**

#### **SECTION 3 – DATA PROTECTION**

THE CLUB WILL USE THE INFORMATION PROVIDED ON THIS ENROLMENT FORM TO ADMINISTER YOUR CHILDS CRICKETING ACTIVITY AT THE CLUB AND IN ANY ACTIVITIES IN WHICH THEY PARTICIPATE THROUGH THE CLUB AND TO CARE FOR AND SUPERVISE ACTIVITIES IN WHICH THEY ARE INVOLVED.

IN SOME CASES THIS MAY REQUIRE THE CLUB TO DISCLOSE THE INFORMATION TO COUNTY BOARDS, LEAGUES AND THE ECB. IN THE EVENT OF A MEDICAL ISSUE OR CHILD PROTECTION ISSUE ARISING, THE CLUB MAY DISCLOSE CERTAIN INFORMATION TO DOCTORS OR OTHER MEDICAL SPECIALISTS AND/OR POLICE, CHILDREN'S SOCIAL CARE, THE COURTS AND/OR PROBATION OFFICERS AND, POTENTIALLY TO LEGAL AND OTHER ADVISERS INVOLVED IN AN INVESTIGATION

#### **SECTION 4 – WEARING OF A HELMET**

IN RECOGNITION OF THE CLUB RULES REGARDING THE WEARING OF HELMETS BY PLAYERS AGED UNDER 18, I CONFIRM THAT MY CHILD WILL WEAR A HELMET WHEN BATTING AGAINST A HARD BALL, AND IF STANDING UP TO THE STUMPS WHEN KEEPING WICKET.
